Living space and non-living space: \$40.00 plus \$0.19 per square foot of each level, or \$40.00 plus 1.5% of construction cost, whichever is less.

Commercial - New Construction, Additions, Alterations, Repairs, etc.:

\$60.00 plus \$0.25 per sq. foot of each level

Commercial and/or Residential: Utility & Miscellaneous Use Groups: New Construction, Additions, Alterations, Repairs, Change of Use, etc. (Sheds, Decks, Pools, Towers, Concrete slabs, etc.): \$60.00 plus \$0.10 per square foot, or \$60 plus 1.5%

of construction cost, whichever is less

Commercial and/or Residential: Fences, Retaining Walls, Elevated Walks, Signs:

Re-inspection fees: Additional inspections after two (2) failed normal inspections: \$50.00 per inspection. **Workmen's Compensation Surcharge of \$25.00 will be applied (as applicable) to every Permit issued for all Construction Projects.** An additional \$100.00 to \$200.00 fee for addressing each complaint and / or violation related to the Worker's Compensation Act. Violations that may occur are Site Visits. Reports and complaint processing, will be reported to the Wayne County District Attorney's Office with all documentation presented for successful prosecution.

An NPDES / Erosion & Sediment Control surcharge of \$50.00 will be applied (as applicable) to every permit issued for all Projects that require any earth disturbance. (Driveway Construction, Septic System Construction, Water Well Construction, Building Construction, Landscaping Projects, etc.), and \$100.00 fee for problems relative to NPDES / E&S that may occur, and will include Site Visits, reports and complaint problem processing, and assigned a \$2,000.00 to \$5,000.00 penalty fee for non-compliance.

Recreational Cabin Exclusion fee: \$100.00 per unit

Escrow Deposits:

- 1. Every applicant, upon submission of any plan where an escrow is required, shall pay to the Township escrow deposits for reasonable and necessary charges by the Township's professional consultants in accordance with applicable schedules.
- 2. The escrow deposit for site plan review referred to herein shall be used to pay for engineering reviews, unusual administrative costs, consultant (including, but not limited to, legal) review of subdivision and land development plans, agreements and performance guarantees and other miscellaneous costs of application review, but does not include a deposit for site inspections and other monitoring during development. The amounts for such review will in no event exceed the rate or cost charged by the Township's consultants for the Township. When the amount of the initial deposit falls below the appropriate minimum amount indicated above, the applicant shall be notified by the Township treasurer to file sufficient monies to bring the balance of the escrow amount initially deposited. Upon final approval of a subdivision or land development plan, and there are no outstanding charges to be placed against the escrow account, whatever remaining funds in the escrow account, upon request shall be returned to the applicant.
- 3. Escrow deposits shall be held without interest.
- 4. Escrow deposits required do not include performance guarantees for completion of improvements shown on submitted plans for subdivisions and land developments.
