ZONING ORDINANCE AMENDMENT – NOISE LEVELS

ORDINANCE NUMBER 3 - 2026

AN ORDINANCE AMENDING THE ZONING ORDINANCE OF DAMASCUS TOWNSHIP,
WAYNE COUNTY, PENNSYLVANIA TO AMEND COMMERCIAL AND
MANUFACTURING PERFORMANCE STANDARDS.

BE IT HEREBY ORDAINED AND ENACTED by the Board of Supervisors of Damascus Township, Wayne County, Pennsylvania, by authority of and pursuant to the provisions of Act of 1968, P.L. 805, No. 247 of the General Assembly of the Commonwealth of Pennsylvania, approved July 31, 1968, as reenacted and amended, known and cited as the "Pennsylvania Municipalities Planning Code," the Damascus Township Zoning Ordinance of August 4, 1997, as follows:

AMEND the Zoning Ordinance of Damascus Township by amending Article IV, Section 405.4 noise §§ A. Maximum Sound Levels, shall be amended to correct a typographical error:

In the Table, the period Saturday, 9:00 p.m.- Monday. 7:00 a.m., Monday-Friday, 9:00 p.m.-7:00 a.m. , Legal Holidays, 12:00-a.m.-12:00 p.m. – Category Limits (dBA), All Others column – replace the value 5 with 50. The resulting table shall be represented thus:

SEVERABILITY

All clauses and provisions of this Ordinance are severable and if any clause or provision should be declared invalid, illegal or unconstitutional for any reason whatsoever, such decision shall not affect or impair the remaining clauses or provisions. It is hereby declared to be the intent that this Ordinance would have been adopted and such unconstitutional, illegal or invalid clauses or provisions been included herein and the clauses and provisions are declared to be severable.

REPEALER

All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed.

AMEND COMMERCIAL AND MANUFACTURING PERFORMANCE STANDARDS


EFFECTIVE DATE

This Ordinance shall be effective five (5) days after enactment hereof.






